The new [Allied Professional initial licensing system](#) and [bill pay system](#) enhance the wide array of services the Medical Board provides on their website located at <http://www.okmedicalboard.org/>.

The [Allied Professional initial licensing system](#) allows allied professionals to apply for a new license or reinstate a previous license online through a simple four-step process. The [bill pay system](#) provides the medical community and customers with the option to pay for a variety of board fees all in a matter of minutes.

The online services provide users with the option to pay with Visa, MasterCard, Discover, American Express, Diners Club, checking or savings accounts. The payments are processed through a secure

payment engine, which abides by rigorous policies and procedures to ensure that users of the system can be confident their payments are safe, private, and secure.
