AGREED ORDER

BEFORE the Court is Verified Motion for Temporary Restraining Order and Temporary and Permanent Injunctions filed by the Plaintiff, The City of Oklahoma City, requesting a temporary injunction and permanent injunction enjoining the Defendant, IAFF, Local 157, from proceeding forward with any grievance pertaining to the formation of the Fiscal Year 2010 collective bargaining agreement between the parties and/or enforcement of the September 2009 decision issued by neutral arbitrator Pedro Molina and IAFF arbitrator Roy L. McGhee (Decision), including but not limited to the grievance submitted to Fire Chief Keith Bryant on May 7, 2010 by Michael Burris on behalf of the IAFF Grievance Committee.

Also before the Court is the Defendant IAFF's Motion to Modify Temporary Restraining Order requesting that this Court modify the Temporary Restraining Order previously granted on June 1, 2010, by requiring the Plaintiff City to post a 1.5 million dollar bond.

The parties have conferred and have reached the following agreement:



1. The Defendant IAFF, Local 157, has agreed to stay proceedings related to the May 7, 2010 grievance referred to above, as well as agreed not to file any additional grievances related to the formation of the Fiscal Year 2010 collective bargaining agreement between the parties and/or enforcement of the Decision, until all proceedings in this case before the Oklahoma County District Court and any appellate court have been finally resolved.


2. In consideration of the agreement described in ¶ 1 above, the Plaintiff City has agreed to withdraw its Verified Motion for Temporary and Permanent Injunctions set for hearing before this Court on July 14, 2010.

It is so **ORDERED** that any and all grievances, including but not limited to the grievance filed on May 7, 2010 by Defendant IAFF, pertaining to the formation of the FY 2010 collective bargaining agreement and/or enforcement of the Decision are hereby **STAYED** until the final and complete resolution of this litigation before this Court or any appellate court.
