Property Detail: Lexington Correctional Center

The Lexington Correctional Center (LCC), situated on 1,344 acres in Lexington, OK, was opened in 1971. The facility initially consisted of a collection of wooden naval barracks hastily constructed during late World War II and had a capacity of 120 inmates. The center remained obscure with virtually no documented history until 1977, when the Lexington Assessment and Reception Center (LARC) opened adjacent.

Department of Corrections and Oklahoma Natural Gas Easement



The new Oklahoma Natural Gas (ONG) pipeline easement through the Lexington prison will use cathodic protection with deep well anode beds, a common way to protect water and gas pipes underground. Modern anodes are more advanced, last longer and fight against soil erosion and other underground issues for a minimum of seven years.

Veterans Affairs and the Ardmore Public Works Authority Easement

The Office of Management and Enterprise Services (OMES) Real Estate and Leasing Services (REALS) recently approved the Ardmore Public Works Authority to replace the water line on the Veterans Affairs property in Ardmore. This is a welcome update for the community, as the old water line continues to flood streets in a local neighborhood.



What is an Easement?

An easement is a right to use another's land for a specific limited purpose. Electric, water, natural gas and other utility companies rely upon easements to bring services to their customers. The OMES REALS office is authorized to grant easements and rights of way, and to enter into contracts authorizing the construction and maintenance of utility, pipeline, railroad and distribution lines. 
Certified Procurement Officer (CPO)
