### MAINTENANCE OF STATE BUILDINGS FUND AND THE LRCPC

The Long Range Capital Planning Commission (LRCPC) is a legislatively appointed body of private citizens who are responsible for recommending the statewide 8-year capital improvements plan and annual capital budget to the governor and legislature. The LRCPC recommended 100 projects be funded for a total of \$29,484,264.00 for the FY 2015 capital budget, and 60 projects at \$34,884,454 for the FY 2016 capital budget. The Legislature approved both proposals and the projects included in those budgets are currently being implemented by OMES in coordination with other agencies.

The Maintenance of State Buildings Revolving Fund was established by the Oklahoma Legislature in 2013 to fund the state's capital improvements plan. The Legislature requires that the proceeds from the sales of state-owned real property be deposited into the fund to implement the capital improvements plan. In addition to sales proceeds, the legislature appropriated \$30 million in FY 2014 and \$15 million in FY 2015 to the fund. To date, approximately \$1.2 million in sales proceeds have been deposited into the fund. These monies

have financed the full FY 2015 capital budget and a portion of the FY 2016 capital budget, allowing the implementation of 118 projects to date.

This new irrigation system for the Department of Agriculture, Food and Forestry's Forest Regeneration Center was a completed project that wouldn't have been possible without this revolving fund.
