**3. Discussion and possible action to approve the commissioning of a portrait of the Governor's mansion commissioned by the Capitol Centennial Committee and sponsored by the Governor and First Gentlemen to go on the first floor of the Governor's Mansion.**

The proposed portrait would depict the Governor's Mansion and its surrounding grounds and is to commemorate the 100<sup>th</sup> anniversary of the Capitol building. The proposed location is in the "Oklahoma Room" over the fireplace on the first floor of the Mansion. The artist, Kenny McKenna, is a local well known artist and respected landscape painter of western scenery.

A preliminary of the portrait will come back before the Commission for sketch/design idea and then for final approval of the painting.

The request is to approve and release the artist to begin the process. The Art Standards Committee met prior to today's meeting and recommended their approval.

The funds for the portrait have been raised by the Capitol Centennial Committee from private donors.

**4. Collections Manager Report. [Alan Atkinson, Director of Visual Arts and Capitol Collections]**

**– Brief update on the Constance Whitney Warren Statue, "*Tribute to the Range Riders*."**

Dr. Atkinson gave a synopsis on the history of the statue and reported that it recently returned to the the Capitol grounds, South Plaza. The statue was cast in 1926 and arrived at the Capitol in 1930 and is known as the first Capitol artwork for the exterior of the building.

A rededication ceremony of the statue and an unveiling of the portrait of the Capitol will be held on July 31, 2018 at 10:00 a.m.
