### 1. Data Delivery for Law Enforcement and Government

Under this transactional pricing structure, an agency may choose to be billed on a purely transactional basis rather than on a monthly flat-rate basis. This pricing requires a \$50 per-month minimum commitment from each agency, regardless of the number of users. Each month the agency would pay \$50 or the total fee for all Accurint searches conducted during the month, whichever is greater.
