AMENDMENT NO. 4 TO CONTRACT MNWNC-102

WHEREAS, the State has a Contract with the Contract Vendor identified as Contract No. MNWNC-102, April 1, 2015, through March 31, 2020 ("Contract"), to provide Computer Equipment; and

WHEREAS, Minn. Stat. § 16C.03, subd. 5, affords the commissioner of Administration, or delegate pursuant to Minn. Stat. § 16C.03, subd. 16, the authority to amend contracts; and



NOW, THEREFORE, it is agreed by the parties to amend the Contract as follows:
