**Questions and Answers**

Question #1 – Do you have a list of the items needed and estimated quantities?

*Answer:* No. Refer to Section 8.1.D of the bidder instructions. The State uses multiple items throughout any given year as well as a variety of agency end users. This contract provides options for the end user to purchase from. Supplier may respond with items they carry or specialize in. Exhibit 1 has 4 tabs which include ammunition, firearms, law enforcement supplies, and value add or service areas. Each tab has a drop-down box which shows our most common purchased brands or category. There is room on the submittal for respondent to add other brands, items, or categories. Respondent may submit a percentage discount by brand or category in the area marked Other. The State would like to see list prices for comparison by either a web-based catalog or current price list.

Question #4 – Is it possible to offer our entire website catalog at a percent discount without individually entering the products?

*Answer:* Yes. Please mark Exhibit 1 with discounts. It is preferable to include brand names or categories along with the discount for identification later in the contract period. List prices must be published.

Question #5 – In reference to the Responding Bidder Information Form, would a Federal Tax ID Number satisfy the requirements under line 2 for FEI/SSN and Supplier ID?

*Answer:* Yes.

Question #6 – In reference to Bidder Instructions, 8.2.H – Section 8, page 9; we believe Response to Specifications and Requirements is not applicable, can the State please confirm?

*Answer:* Confirmed. Since this is a discount from list, this project contains multiple areas and does not have detailed item specifications.

Question #7 – In reference to Bidder Instructions, 8.2.K – Section 11, page 9; we believe Financial Information is not applicable; can the State please confirm or provide guidance as to the requested Financial Information?

*Answer:* Confirmed. This RFP does not require business financial statements. It does require business references however.

Question #8 – In reference to Excel Attachment: Pricing Submittal, Tab 3 (Category 3-Law Enforcement Supply)' we believe this file has an inadvertent omission of an "Accessories" option in the drop-down menu. Can we have this added and updated, or how would the Government propose we include pricing for these components?

*Answer:* There is space at the bottom of each tab marked Other. Please use this space to include alternate items, categories, or brands.

Question #9 - Section 8.1 (D) references D&O Insurance plus EPL and Consultant's Computer E&O Coverage, if IT technology services are provided. Are we correct in understanding that that entire section only applies if IT services are provided under the Contract?

*Answer:* Correct. The mentioned section only applies to IT components.

Question #10 - Section 8.1 ( E) references "Security and Privacy Liability insurance, including coverage for failure to protect confidential information and failure of the security of Supplier's computer systems that results in unauthorized access to Customer data with limits \$5,000,000 per occurrence." Is this requirement required for all vendors regardless of services provided or, similar to section 8.1(D), only if IT services are provided and the Supplier is not retaining Personal or Confidential Records such as names, addresses, social security numbers or health care data?

*Answer:* This section does only apply if IT components are included within your response.
