This State of Oklahoma Statewide Contract (SW0012) is entered into between the state of Oklahoma by and through the Office of Management and Enterprise Services and FOLLETT SCHOOL SOLUTIONS INC ("Supplier") and is effective from September 1, 2021.

Purpose



1. The parties agree that Supplier has not yet begun performance of work under this Contract. Upon full execution of this Contract, Supplier may begin work. Issuance of a purchase order is required prior to payment to a Supplier.

If and to the extent any provision is in multiple documents and addresses the same or substantially the same subject matter but does not create an actual conflict, the more recent provision is deemed to supersede earlier versions.
