



**STATE OF OKLAHOMA AMENDMENT No. 1 TO STATEWIDE CONTRACT
AMENDMENT CONTRACT WITH USIC LOCATING SERVICES, LLC.**


This Amendment No. 1 (“Amendment”) to Statewide 1031 for Cable/Fiber Locate Services (“Contract”) is effective on the date of the last signature below (the “Amendment Effective Date”) and is entered into between the State of Oklahoma by and through the (“State”) and USIC Locating Services, LLC (“Supplier”). This Amendment supplements and amends the Contract effective November 29, 2021, including all supplements and amendments thereto. Unless otherwise indicated herein, capitalized terms used in this Amendment without definition shall have the respective meanings specified in the Contract.

For good and valuable consideration, the parties agree to amend the Contract as follows:

1. This Amendment is a price change pursuant to section 2.1.6 of the Contract.
2. The current rate in the Contract is amended with a 3% increase as outlined in Attachment A.
3. Attachment A is incorporated herein.
4. In the event of a conflict between the terms and conditions hereof and the terms and conditions of the Contract, the specific terms set forth in this Amendment shall govern the subject matter herein.
5. Except as expressly modified in this Amendment, all terms and/or provisions of the Contract not addressed herein remain as executed by the parties in the Contract and remain in full force and effect.
6. This Amendment may be executed by electronic signature in counterparts (e-mail, facsimile or otherwise). The counterparts each of which shall constitute an original, but all of which together shall constitute one and the same instrument.


