**STATE OF OKLAHOMA AMENDMENT No. 2 TO STATEWIDE CONTRACT  
AMENDMENT CONTRACT WITH CONCENTRA HEALTH SERVICES, INC.**

This Amendment No. 2 (“Amendment”) to SW0555 for Alcohol and Drug Testing Services (“Contract”) is effective on the date of the last signature below (the “Amendment Effective Date”) and is entered into between the State of Oklahoma by and through the Office of Management and Enterprise Services (“State”) and Concentra Health Services, Inc. (“Supplier”). This Amendment supplements and amends the Contract effective August 3, 2023, including all supplements and amendments thereto. Unless otherwise indicated herein, capitalized terms used in this Amendment without definition shall have the respective meanings specified in the Contract.

For good and valuable consideration, the parties agree to amend the Contract as follows:

1. This Amendment is a mutual agreement to change the pricing in the Contract, and renew the contract for a one-year period through August 2, 2025. The two additional one-year renewal options remaining in the Contract will be auto renewed. If either party chooses not to renew a notice shall be sent 30 days prior to the renewal date.
2. Attachment A is incorporated herein and provides the updated pricing.
3. In the event of a conflict between the terms and conditions hereof and the terms and conditions of the Contract, the specific terms set forth in this Amendment shall govern the subject matter herein.
4. Except as expressly modified in this Amendment, all terms and/or provisions of the Contract not addressed herein remain as executed by the parties in the Contract and remain in full force and effect.
5. This Amendment may be executed by electronic signature in counterparts (e-mail, facsimile or otherwise). The counterparts each of which shall constitute an original, but all of which together shall constitute one and the same instrument.
