



STATE OF OKLAHOMA AMENDMENT TO SOURCEWELL PARTICIPATING AGREEMENT

This First Amendment ("Amendment") to the Sourcewell Participating Agreement by and between the State Of Oklahoma ("Buyer") and Staples Contract & Commercial LLC (f/k/a Staples Contract & Commercial, Inc.) ("Supplier") made effective as of August 1, 2020 ("Agreement") is effective on February 3, 2025. Buyer and Supplier are collectively referred to herein as the "Parties". Unless otherwise indicated herein, capitalized terms used in this First Amendment shall have the meaning assigned to them in the Participating Agreement.

For good and valuable consideration, the parties agree to amend the Participating Agreement as follows:

1. The parties desire to amend the Participating Agreement to extend the Service Term.

2. The parties agree to amend Section 2.0 **Term** of the Participating Agreement so that the existing Section 2.0 **Term** is hereby modified and amended as follows:

2.0 Term. The term of this Participating Agreement with respect to the Buyer shall commence on the Participating Agreement Effective Date and shall terminate on July 31, 2025. When the Participating Agreement terminates, Staples agrees to offer Buyer the option to enter into a separate agreement with Staples only, provided, however, Staples and Buyer mutually agree upon the terms and conditions of such separate agreement.

3. The parties additionally agree to amend Section 3.2 of the Participating Agreement and it is hereby amended to the following:

3.2 **Sourcewell Program.** The specific program below:

Supplies Program. Office, school, and other workplace-related supplies and services offered for sale by Staples to Sourcewell members that are included in the Sourcewell national contract solution for the procurement of OFFICE SUPPLY CATALOG SOLUTIONS pursuant to the SW Contract tied to RFP award # 070924-SCC.

4. In the event of a conflict between the terms and conditions hereof and the terms and conditions of the Participating Agreement, the specific terms set forth in this Amendment shall govern the subject matter herein.

5. Except as expressly modified in this Amendment, all terms and/or provisions of the Participating Agreement not addressed herein remain as executed by the parties in the Participating Agreement and remain in full force and effect.

6. This Amendment may be executed by electronic signature in counterparts (e-mail, facsimile or otherwise). The counterparts each of which shall constitute an original, but all of which together shall constitute one and the same instrument.
