## MINUTES OF THE MEETING OF THE BOARD November 8, 2024

The Oklahoma State Board of Examiners of Psychologists Meeting began at 10:00 a.m. on Friday, November 8, 2024. The meeting was held at the NICHOLSON TOWER (OUHSC) NICHOLSON CONFERENCE CENTER, 1000 NE 13<sup>th</sup> Street, Suite 5700 – Room C, Oklahoma City, OK 73104.

In attendance were: S. Sternlof, Ph.D., Chair of the Board; Alan Ivy, Ph.D., Vice-Chair of the Board; K. Choate, Ph.D., Member of the Board; W. Berman, Member of the Board; M. Shepherd, Ph.D., Member of the Board; R. Pollard, Member of the Board; C. Kunzweiler, Member of the Board; B. Warren, Assistant Attorney General; T. Rose, Executive Director of the Board.

#### Announcement and Introduction:

Dr. Sternlof announced that a quorum was present to conduct business. He confirmed with Director Rose that the meeting was filed with the Secretary of State, and the agenda was posted in accordance with the Open Meeting Act.

#### Statement of the Mission of the Oklahoma State Board of Examiners of Psychologists:

Dr. Sternlof announced the mission of the Oklahoma State Board of Examiners of Psychologists is to protect the public by regulating the practice of psychology in Oklahoma to ensure that only properly qualified psychologists practice psychology in the state and that the psychology profession as a whole is conducted in the public's best interest.

#### Approval of Minutes:

Board members reviewed the meeting minutes for July 19, 2024. *Ms. Pollard moved to approve the July 19, 2024, meeting minutes. Dr. Choate seconded the motion and the motion passed. Pollard, Shepheard, Kunzweiler, Ivy, Choate, and Sternlof voted for the motion.* 

Board members reviewed the meeting minutes for September 27, 2024. *Dr. Kunzweiler moved to approve the September 27, 2024, meeting minutes. Dr. Shepherd seconded the motion and the motion passed. Pollard, Shepherd, Kunzweiler, Ivy, Choate, and Sternlof voted for the motion.* 

Dr. Berman arrived at the meeting.

#### Report from the Oklahoma Psychological Association.

On behalf of the Oklahoma Psychological Association, Dr. Emily Corley and Ms. Fowble provided updates on the OPA Masters Level Licensure Taskforce, Forensic Psychology Taskforce, and current legislative matters. Additionally, Ms. Fowble presented Ms. Rose with a photograph from the Governor's Bill Signing Ceremony for HB 1345, the Psychology Reciprocity Bill, which allows the Board to enter into an agreement of reciprocity with other states.

## Association of State and Provincial Psychology Boards (ASPPB) - Examination for Professional Practice in Psychology (EPPP) (Part 1 – Knowledge and Part 2 - Skills):

Board members were provided with the October 22, 2024, letter from ASPPB, "A New Path Forward: Prioritizing Resolution Over Conflict," and information about the discussion session for ASPPB jurisdictional and individual members on October 30, 2024, regarding the EPPP (Part 2-Skills), and the proposed bylaw amendment. *No action was taken*.

#### Revised Application for Licensure via Endorsement or Reciprocity:

Ms. Rose presented revisions to the Application for Licensure via Endorsement or Reciprocity. Dr. Choate made a motion to accept the revisions to the application as presented. Dr. Ivy seconded the motion and the motion passed. Berman, Pollard, Shepherd, Kunzweiler, Ivy, Choate, and Sternlof voted for the motion

# Psychological Technician Committee report and presentation of revisions to the Psychological Technicians' Activities and Their Representation to the Public and business card template for Psychological Technicians, as provided in OAC 575:10-1-7(f)(2):

Board members reviewed the committee report and revisions to the Psychological Technicians' Activities and Their Representation to the Public document and the Business Card template for technicians. After discussion, additional amendments were presented. *Dr. Choate motioned to accept the Psychological Technicians' Activities and Their Representation to the Public document and Business Card template as amended. Dr. Kunzweiler seconded the motion and the motion passed. Berman, Pollard, Shepherd, Kunzweiler, Ivy, Choate, and Sternlof voted for the motion.*

Ms. Rose presented revisions to the Institutional/Private Practice Under Supervision Extension Request form. *Dr. Sternlof motioned to accept the revisions as presented. Dr. Shepherd seconded the motion and the motion passed. Berman, Pollard, Shepherd, Kunzweiler, Ivy, Choate, and Sternlof voted for the motion.* 

#### Rules Committee report and recommendation:

On behalf of the Rules Committee, Ms. Rose recommended postponing rule changes this session. *No action was taken.* 

### Current Continuing Professional Education Requirements and possible appointment of committee:

Dr. Berman provided alternative continuing education requirement options for the board members to consider. Dr. Sternlof made a motion to develop a committee consisting of three board members to evaluate the current continuing education requirements. Dr. Choate seconded the motion and the motion passed. Berman, Pollard, Shepherd, Kunzweiler, Ivy, Choate, and Sternlof voted for the motion.

#### Appointment of an additional Application Review Committee Member:

Board members discussed the need for an additional Application Review Committee Member to serve on the committee as needed. Dr. Sternlof motioned to appoint a board member as needed. Dr. Choate seconded the motion passed. *Berman, Pollard, Shepherd, Kunzweiler, Ivy, Choate, and Sternlof voted for the motion.* 

#### Applications approved by the Application Review Committee September – October 2024:

Dr. Choate motioned to ratify the application approved September – October 2025 by the review committee. Ms. Pollard seconded the motion and the motion passed. *Berman, Pollard, Kunzweiler, Ivy, and Choate voted for the motion. Shepherd and Sternlof recused.*
