**Ordinance # 2008-1**

AN ORDINANCE ANNEXING CERTAIN DESCRIBED PROPERTY INTO THE CITY LIMITS OF THE TOWN OF DAVENPORT, OKLAHOMA; REPEALING ALL ORDINANCES AND REGULATIONS IN CONFLICT HERewith: PROVIDING FOR SEVERABILITY; AND DECLARING AN EMERGENCY.

**EMERGENCY ORDINANCE**

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF DAVENPORT, OKLAHOMA:

**Section 1.**

That the following described property located in Lincoln County, Oklahoma, be annexed into the Town of Davenport, Oklahoma, to-wit:

Quail Ridge Addition, being a part of the Southeast Quarter (SE/4) of Section Four (4), Township Fourteen (14) North, Range Five (5) East of the Indian Meridian, Lincoln County, Oklahoma,

And more particularly described as: A tract of land in the Southeast Quarter (SE/4) of Section Four (4), Township Fourteen (14) North, Range Five (5) East of the Indian Meridian, Lincoln County, Oklahoma, being described as: Beginning at the SE/c of said Section Four (4); thence S 89°55'56" W a distance of 500.00 feet; thence N 00°11'08" E a distance of 722.09 feet; thence N 49°01'52" W a distance of 191.48 feet; thence N 00°11'08" E a distance of 1270.00 feet; thence N 89°23'43" W a distance of 680.58 feet; thence N 00°06'10" E a distance of 520.00 feet; thence N 89°53'10" E a distance of 1326.32 feet; thence S 00°11'08" W a distance of 2646.87 feet to the point of beginning, now platted as Quail Ridge Addition.



**Section 2.**

That all ordinances in conflict herewith are hereby repealed.

**Section 3.**

That the provisions of this ordinance are severable and if any part or provision hereof shall be held void by a court of competent jurisdiction, such decision shall not affect or impair any of the remaining parts or provisions of this ordinance.


**Section 4.**






# Davenport, Oklahoma Lincoln County
