

ANNEXATION ORDINANCE FOR THE TOWN OF GOLDSBY, OKLAHOMA

ORDINANCE NUMBER 85-6

AN ORDINANCE extending the city limits of the Town of Goldsby, Oklahoma, to include all that land included in an area described as follows:

(A) E 1/2 Section 1, (Except W 1/2, SW 1/4, SE 1/4, 20A) Section 1, Township 7N, Range 3 West, McClain County, Oklahoma;

(B) E 1/2 NW 1/4, NE 1/4, E 1/2, SE 1/4 Section 12, Township 7 North, Range 3 West, McClain County, Oklahoma;

(C) All of Section 17, Township 7 North, Range 2 West, McClain County, Oklahoma;

(D) E 1/2 Section 18, Township 7 North, Range 2 West, McClain County, Oklahoma;

(E) N 1/2 Section 20, Township 7 North, Range 2 West, McClain County, Oklahoma;

(F) SW 1/4, SW 1/4, NE 1/4, Lots 8, 13 & 18--in SW, NE, and S 1/2, and NW 1/4, Section 8, Township 7 North, Range 2 West, McClain County, Oklahoma;

(G) Part of NW 1/4 lying West of the Interstate Highway 35 consisting of 33.11 A. Section 5, Township 7 North, Range 2 West, McClain County, Oklahoma;

(H) All of Section 6, West Ladd Road and Interstate Highway 35. Section 6 Township 7 North, Range 2 West, McClain County, Oklahoma;

(I) All of Section 7 in Township 7 North, Range 2 West, McClain County, Oklahoma;

effective immediately upon passage and publication; and declaring an emergency.

WHEREAS, a Petition for Annexation has been presented to the Board of Trustees of the Town of Goldsby, Oklahoma; said petition being signed by three-fourths of the owners of the property (in value) and three-fourths of the legal voters of the said area,

AND WHEREAS, Notice of a Hearing on the said petition has been published once each week for two consecutive weeks, according to law, in the Purcell Register, a legal newspaper, published in Purcell, McClain County, Oklahoma,

AND WHEREAS, it appears that such allegations in the said petition are true and correct,

AND WHEREAS, it appears for the best interest of the Town of Goldsby, Oklahoma, and the citizens and residents thereof, that the said petition be granted;

**NOW, THEREFORE, THE BOARD OF TRUSTEES
OF THE TOWN OF GOLDSBY ORDAINS:**

Section 1. The Town Limits of the Town of Goldsby, Oklahoma, be extended to include the following described property , to wit:

(A) E 1/2 Section 1, (Except W 1/2, SW 1/4, SE 1/4, 20A) Section 1, Township 7N, Range 3 West, McClain County, Oklahoma.;

(B) E 1/2 NW 1/4, NE 1/4, E 1/2, SE 1/4 Section 12, Township 7 North, Range 3 West, McClain County, Oklahoma.;

(C) All of Section 17, Township 7 North, Range 2 West, McClain County, Oklahoma.;

(D) E 1/2 Section 18, Township 7 North, Range 2 West, McClain County, Oklahoma.;

(E) N 1/2 Section 20, Township 7 North, Range 2 West, McClain County, Oklahoma.;

(F) SW 1/4, SW 1/4 , NE 1/4, Lots 8, 13, & 18--in SW, NE, and S 1/2 and NW 1/4, Section 8, Township 7 North, Range 2 West, McClain County, Oklahoma.;

(G) Part of NW 1/4 lying West of the Interstate Highway 35 consisting of 33.11 A. Section 5, Township 7 North, Range 2 West, McClain County Oklahoma.;


(H) All of Section 6, West Ladd Road and Interstate Highway 35. Section 6 Township 7 North, Range 2 West, McClain County, Oklahoma.;

(I) All of Section 7 in Township 7 North, Range 2 West, McClain County, Oklahoma.,

all of the above described territory is hereby annexed into said town.

Section 2. That for the preservation of the public peace and safety, an emergency is hereby deemed to exist by reason whereof this ordinance shall take effect, and be in full force and effect immediately from and after its passage, approval and publication.






