

## ORDINANCE NO. 960

AN ORDINANCE ANNEXING TO THE CITY OF HENRYETTA, OKLAHOMA, CERTAIN TERRITORY ADJACENT TO SAID CITY, AND INCREASING, EXTENDING AND ESTABLISHING THE CORPORATE LIMITS OF THE CITY OF HENRYETTA, OKLAHOMA, AND DECLARING AN EMERGENCY.

WHEREAS, its is the opinion of the City Council of the City of Henryetta, Oklahoma, that it is desirable at this time to extend the limits of said City, by annexing the herein after described tract and parcel of land to the city of Henryetta, Okmulgee County, State of Oklahoma, as the same is now constituted; and

WHEREAS, a majority of the owners of the real property to be annexed have consented in writing to said annexation.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HENRYETTA;

SECTION ONE (1): That the following territory adjacent or contiguous to the City of Henryetta, Oklahoma, as the same is, hereby annexed to and made a part of the City of Henryetta, State of Oklahoma, To-wit:

The East Half of the Northeast Quarter (E ½ NE ¼) East of the Indian Nation Turnpike right of way in Section Thirty (30), Township 11 North Range 13 East, and the Southeast Quarter (SE ¼) East of the Indian Nation Turnpike right of way in Section Nineteen (19), Township 11 North, Range 13 East, all In Okmulgee County, State of Oklahoma.

SECTION TWO (2): That the present boundaries and limits of the City of Henryetta, Oklahoma, as they are now constituted, be, and the same are, hereby extended, so as to include and embrace within the limits of said City of Henryetta, State of Oklahoma, all of the above described land.


