


ORDINANCE NO. 2006- 1075



AN ORDINANCE CHANGING THE LIMITS OF THE TOWN OF HYDRO, BLAINE COUNTY, OKLAHOMA, BY ANNEXING THERETO THE TERRITORY HEREINAFTER DESCRIBED: PROVIDING THAT INVALIDITY OF A PART SHALL NOT INVALIDATE THE REMAINDER: REPEALING ALL ORDINANCES IN CONFLICT HEREWITH: AND DECLARING AN EMERGENCY.

Be it ordained by the Board of Commissioners of the Town of Hydro, Oklahoma:

Section I. That the Town limits of the Town of Hydro, Oklahoma, are hereby declared to be changed, to the extent of, and for the purpose of including within said Town of Hydro, Oklahoma, the following pieces, parcels or tracts of land described as:

A tract of land lying in the SW/4 of Section 34, Township 13 North, Range 13 W.I.M., Blaine County, Oklahoma, described as follows:

Beginning at the NE/Corner of Arbes 3rd Addition of the Town of Hydro, Blaine County, Oklahoma; thence West and along the North line of said Arbes 3rd Addition a distance of 1362.50 feet, thence N 0° 08' 30" W a distance of 415.00 feet; thence East a distance of 1362.50 feet to a point on the East line of said SW/4; thence S 0° 08' 30" E and along said East line a distance of 415.00 feet to the point of beginning, containing 12.98 acres, more or less.

Section II. That said annexed land is declared to be zoned residential.

Section III. The above described land is hereby annexed to, and made a part of the Town of Hydro, Blaine County, Oklahoma, pursuant to consent and petition of Terral Klaassen and Pam Klaassen, husband and wife, as joint tenants, the owners of the respective tract of land.

Section IV. Should any part of this Ordinance be held by any Court of competent jurisdiction to be invalid, or be held to be invalid with reference to any part, parcel or portion of the land above described, such holding shall not affect the validity of said Ordinance with reference to the remainder of said Ordinance or of said land.

Section V. All Ordinances in conflict herewith are hereby specifically repealed.
