CITY ORDINANCE NO. 556  
(2<sup>nd</sup> Amendment)  
Correct legal description of Tract No. 4.

WHEREAS, City Ordinance No. 556 and Amendment to City Ordinance No. 556 was passed on the 20<sup>th</sup> day of March 2001.

WHEREAS, Tract No. 4 in said Ordinance contained an incorrect legal description of the proposed annexed territory.

WHEREAS, the same should be amended to correct the legal description of Tract No. 4 of City Ordinance No. 556 to property annexed by the City of Idabel.

NOW, THEREFORE BE IT ORDAINED by the Mayor and Council in and for the City of Idabel, Oklahoma, that the corporate limits of the City of Idabel, Oklahoma, be and they are hereby extended to include the following property located and situated in McCurtain County, to-wit:

Begin at a point 50 feet South and 660 feet West of the NE Corner of Lot 3 of Section 3, Township 8 South, Range 24 East of the IBM, said point being on the South R/W line of State Highway 3; thence South 585.25 feet; thence West 660 feet; thence North 582.94 feet to a point on the South right of way line of State Highway 3; thence East 660 feet to the point of beginning, containing 845 acres, more or less;

And,

Begin at a point 50 feet South of the NE Corner of Lot 3 of Section 3, Township 8 South, Range 24 East, said point being on the South right of way line of State Highway No. 3; Run thence South 587.56 feet; thence West 660 feet; thence North 585.25 feet to a point on the South right-of-way line of SH 3; thence East 660 feet to the point of beginning, containing 8.88 acres, more or less;

And,

Begin at a point 143.50 feet East of the SW Corner of the SW 1/4 NW 1/4 of Section 3, Township 8 South, Range 24 East of the IBM; Run thence East 516.50 feet; thence North 330 feet; thence West 516.50 feet to a point on the East right of way line of the US Highway No. 70 By-Pass; thence South along said right of way line 330 feet to the point of beginning, containing 3.91 acres, more or less;

And,

The E 1/2 E 1/2 SW 1/4 NW 1/4 and the SE 1/4 NW 1/4 and the S 1/2 of Lot 3 and the SW 1/4 SE 1/4 SW 1/4 NW 1/4 of Section 3, Township 8 South, Range 24 East.

PASSED AND THE EMERGENCY CLAUSE ruled upon separately by the Council of the City of Idabel, Oklahoma, and signed by the Mayor of said City this June 5<sup>th</sup>, 2001
