To the People of Oklahoma:

I am pleased to issue the June monthly investment performance report for the Office of the State Treasurer. I trust you will find it thorough and in keeping with my commitment to provide full and complete disclosure of all activities within my office. As always, my staff and I are available to answer any questions you might have.

Market Conditions

Yields on U.S. Treasury securities were mixed at month-end. From three-month Treasury bills to five-year Treasury Notes yields were up and from seven-year Treasury Notes to the benchmark 30-year Treasury bond yields were down. U.S. stocks fell in June but the Dow Jones Industrial Average (DJIA) finished the second quarter up 11%, its best gain since 2003. It remains down 40% from its all-time high on October 9, 2007. The S&P 500 index finished June up, 15% for the quarter and up 1.8% for the year. The advance from April through June broke a streak of six consecutive quarterly declines for the S&P 500, the longest since 1970. The Federal Open Market Committee (FOMC) left the target fed funds rate unchanged at a range of 0% to 0.25% at its June meeting. The FOMC statement released at the conclusion of the two-day meeting on June 24 hinted at possible changes to the central bank's liquidity and bond purchase programs. The FOMC did not make any changes in the outright purchase programs for Treasuries, Agencies, or Mortgage-Backed Securities (MBS). The committee expects "that inflation will remain subdued for some time."

Economic Developments

The Institute for Supply Management reported that its index of manufacturing activity rose to 42.8 for May from 40.1 in April. The unemployment rate for May jumped to 9.357% from 8.9% in April and is the highest U.S. unemployment rate since 1983. Six million jobs have been lost since the recession started. Average weekly hours fell to a record low 33.1 hours and average hourly earnings inched up 0.1% for the month. The median length of unemployment surged to 14.9 weeks in May from 12.5 weeks in April. Nearly 50% of those unemployed stay that way for at least 15 weeks. The producer price index (PPI) for finished goods increased 0.2% in May. Core prices, excluding food and energy fell 0.1% for the month, the first decrease since October 2006. The PPI was down 5% from one year ago, the biggest decline since August 1949. Retail sales in May increased 0.5% after declining 0.2% the prior month. The improvement was mostly due to auto sales as consumers took advantage of deals on cars made by Chrysler and GM. The consumer price index (CPI) rose 0.1% in May from April. Compared to a year earlier, the CPI was down 1.3%, the largest decline since 1950. The Conference Board's consumer confidence index fell to 49.3 in June from 54.8 the month before. The Bureau of Economic Analysis reported gross domestic product (GDP) fell by 5.5% at an annual rate.

Portfolio Commentary: Performance, Diversification, and Strategy

Yield on the Treasurer's portfolio was 3.37% in June and the weighted average maturity was 515 days. Continuing to decline, the year-to-date monthly average investable base fell \$31 million to \$3.853 billion. Since February the base number is down almost \$122 million. Portfolio diversification continues to be sound. U.S. Treasuries represented 8% of holdings, and U.S. government sponsored enterprises accounted for approximately 42%. Mortgage-backed securities were 21%, Municipal Bonds were 2% and Certificates of Deposit represented 6% of assets. Money market mutual funds were 7% and 10% was maintained in overnight repurchase agreements. Link deposits (at less than 1%), State Bond Issues (at 3%) and foreign bonds (at less than 1%) made up the balance of funds invested. In keeping with the State's statutory investment objectives, the portfolio strategy continues to seek safety, liquidity, and return on investment, in that order. Based on market conditions, portfolio strategy will consist of a combination of laddered maturities and market observation for investment opportunities.

Collateralization

All funds under the control of this office requiring collateralization were so secured at rates ranging from 102% to 110%, depending on the type of investment.

Payments, Fees, and Commissions

All securities were purchased or sold on a net basis utilizing competitive bidding where practicable, with no additional fees or commissions known to the State Treasurer. Bank fees, mutual fund operating expenses and fees charged by JPMorgan Chase for the Tri-Party Repurchase Agreement Program are detailed in the attached pages, as is the earnings split between the Treasurer and the master custodian bank on securities lending income.



In February 2008, the Treasurer estimated earnings to the Board of Equalization for Fiscal Year 2009. The amount estimated was \$146,500,000. Year-to-date actual earnings are recorded on a cash basis of accounting.

Explanation of Performance Comparison

June 30, 2009

The following page presents market rates of return on the Securities portion of the General Account and of the State's aggregated State Agency Accounts. The figures, which are dollar- and time-weighted, where appropriate, are calculated using the percentage change in market value (inclusive of accrued income) from the end of the prior month to the end of the reporting month. To ensure the integrity of the data, this information is provided by the Treasurer's custodian bank acting in its capacity as an external third party. As such, performance measurement is presently confined to those investments which are custodied at Northern Trust ("Northern").

The Treasurer's office is trying to develop a method to report rates of return on all investment instruments in the State's portfolio. This is in an effort to report return data in a manner recommended on September 15, 1994, by the Working Group of the Cash Management and Investment Oversight Commission. However, there are technical and conceptual challenges to expanding performance measurement to other portions of the portfolio. Attempting to apply market-base pricing calculations to instruments which do not trade, such as Certificates of Deposit, presents difficulty which is both conceptual and technical in nature.



The State Treasurer participates in a Securities Lending Program with The Northern Trust Company ("Northern") acting as lending agent. Northern retains 25% of the revenues generated as compensation for services. Its share for the month was \$26,764.25. Pursuant to Oklahoma State Statute Title 62 Section 90, the State Treasurer retains the first \$425,000 of securities lending revenues in a revolving fund. These funds are used to pay custody and other banking fees. Any revenue not needed for this purpose is deposited to the General Fund.
