To the People of Oklahoma:

I am pleased to issue the November monthly investment performance report for the Office of the State Treasurer. I trust you will find it thorough and in keeping with my commitment to provide full disclosure of all activities within my office. As always, my staff is available to answer any questions you might have.

Market Conditions

Rates on the yield curve fell an average of 55 basis points in November as concerns about banks' willingness to loan money drove investors to the safety of U.S. government debt. The yield on the two-year note fell 78 basis points, the biggest drop since June 1989. As crude oil climbed to a record \$97 a barrel in New York, energy and metal producers helped U.S. stock markets to hit monthly highs on November 6th. The Dow Jones Industrial Average (DJIA) increased 117 points to 13,660, the Nasdaq Composite rose 30 to 2,825 the Standard & Poor's 500 Index (S&P 500) climbed 19 to 1,521. As concern about mounting mortgage losses increased U.S. stocks fell on November 26th pushing 2007 record highs down more than 10%. At month-end the DJIA was 13,371, the Nasdaq Composite 2,660 and the S&P 500 was 1,483. The Federal Open Market Committee (FOMC) did not meet in November.

Economic Developments

The Institute for Supply Management reported that its index of manufacturing activity slipped to 50.9 in October from 52 in September. Manufacturers reported they paid more for materials such as oil and steel in October. The unemployment rate for October remained at 4.7%. U.S. average hourly earnings were up 3.8% from a year ago. The producer price index (PPI) rose just 0.1% in October. Food prices were up 1%. Slower consumer spending resulted in only a 0.2% increase in retail sales in October. Purchases at service stations increased by 0.8% and that probably reflected higher gasoline prices. Sales at furniture stores, department stores and sporting goods stores fell in October. Non-store retailers, such as internet merchants, saw a 1% decline in demand. Unseasonably warm weather decreased the demand for jackets and sweaters. The consumer price index (CPI) rose 0.3% in October. Rising energy costs were somewhat offset by tame prices for housing and discretionary spending. The trade deficit shrank 0.6% to \$56.8 billion in September. The Conference Board's consumer confidence index fell to 87.3 in November, from a revised 95.2 in October. The National Association of Realtors reported that sales of previously owned homes declined by 1.2% in October, the eighth consecutive monthly decline. Total existing home sales for October fell to their lowest level since the NAR compiled the data beginning in 1999. THE NAR months' supply of total homes on the market increased to 10.8 from 10.4 in September. The sharp rise in homes on the market will put downward pressure on sale prices.

Portfolio Commentary: Performance, Diversification, and Strategy

Yield on the Treasurer's portfolio was 4.77% in November and the weighted average maturity was 439 days. Funds from maturing investments and overnight repurchase agreements were moved into Mortgage-backed securities and Commercial Paper. The year-to-date monthly average investable base was \$3.624 billion, down slightly from October's \$3.630 billion. Portfolio diversification continues to be sound. U.S. Treasuries represented 15% of holdings, and U.S. government sponsored enterprises accounted for approximately 46%. Mortgage-backed securities were 6% and Commercial Paper was 4%. Certificates of Deposit represented 9% of assets, money market mutual funds were 7%, and 9% was maintained in overnight repurchase agreements. Link deposits (at 1%), State Bond Issues (at 2%) foreign bonds (at less than 1%) made up the balance of funds invested. In keeping with the State's statutory investment objectives, the portfolio strategy continues to seek safety, liquidity, and return on investment, in that order. Based on market conditions, portfolio strategy will consist of a combination of laddered maturities and market observation for investment opportunities.

Collateralization

All funds under the control of this office requiring collateralization were so secured at rates ranging from 102% to 110%, depending on the type of investment.

Payments, Fees, and Commissions

All securities were purchased or sold on a net basis utilizing competitive bidding where practicable, with no additional fees or commissions known to the State Treasurer. Bank fees, mutual fund operating expenses and fees charged by JPMorgan Chase for the Tri-Party Repurchase Agreement Program are detailed in the attached pages, as is the earnings split between the Treasurer and the master custodian bank on securities lending income.



In February 2007, the Treasurer estimated earnings to the Board of Equalization for Fiscal Year 2008. The amount estimated was \$152,845,269. Year-to-date actual earnings are recorded on a cash basis of accounting.

Explanation of Performance Comparison November 30, 2007

The following page presents market rates of return on the Securities portion of the General Account and of the State's aggregated State Agency Accounts. The figures, which are dollar- and time-weighted, where appropriate, are calculated using the percentage change in market value (inclusive of accrued income) from the end of the prior month to the end of the reporting month. To ensure the integrity of the data, this information is provided by the Treasurer's custodian bank acting in its capacity as an external third party. As such, performance measurement is presently confined to those investments which are custodied at Northern Trust ("Northern").

The Treasurer's office is trying to develop a method to report rates of return on all investment instruments in the State's portfolio. This is in an effort to report return data in a manner recommended on September 15, 1994, by the Working Group of the Cash Management and Investment Oversight Commission. However, there are technical and conceptual challenges to expanding performance measurement to other portions of the portfolio. Attempting to apply market-base pricing calculations to instruments which do not trade, such as Certificates of Deposit, presents difficulty which is both conceptual and technical in nature.



The State Treasurer participates in a Securities Lending Program with The Northern Trust Company ("Northern") acting as lending agent. Northern retains 25% of the revenues generated as compensation for services. Its share for the month was \$92,778.97. Pursuant to Oklahoma State Statute Title 62 Section 90, the State Treasurer retains the first \$425,000 of securities lending revenues in a revolving fund. These funds are used to pay custody and other banking fees. Any revenue not needed for this purpose is deposited to the General Fund.
