To the People of Oklahoma:

I am pleased to issue the October monthly investment performance report for the Office of the State Treasurer. I trust you will find it thorough and in keeping with my commitment to provide full and complete disclosure of all activities within my office. As always, my staff and I are available to answer any questions you might have.

Market Conditions

In fixed income markets, U.S. Treasuries reflected little price change during October. The two-year Treasury began the month at 0.63% and closed at 0.72%, the ten-year started at 2.03% and ended at 2.14%. The five-year maturity closed at 1.52%, which was a 0.16% gain from the first of the month. The 30-year came in at 2.92%.

The stock market finished strong in October with its highest monthly gain in four years. The S&P 500 index climbed for five consecutive weeks and closed the month up 8.3%, its best month since October 2011. The S&P 500 came in at 2,079, the Dow Jones industrial average at 17,663 and the Nasdaq composite index finished at 5,053.

Chairman Yellen and the Federal Open Market Committee (FOMC) elected to leave rates unchanged and continue the zero rate policy for the 83rd consecutive month. The FOMC meeting minutes reflected no change to language addressing inflation, continuing the view that it is coming in below the longer-run objective of the Committee. The minutes reiterated the Committee will continue to scrutinize the international marketplace. Richmond Fed president Jeffrey Lacker voted against not increasing the federal funds rate and said it should be increased by 0.25%.

Economic Developments

The September unemployment rate was 5.1%, reflecting no change from the month before. The September non-farm payrolls figure was 142,000 and the previous month was revised down by 37,000. The labor force participation rate dropped from 62.2% to 62.4% and average hourly earnings remained unchanged. Year-to-date job growth in 2015 averaged 198,000 per month, compared with an average of 260,000 in 2014. The average work week remained unchanged at 34.6 hours.

The consumer price index (CPI) in September dropped by 0.2% and the headline CPI remained flat. The core CPI, which excludes food and energy costs, jumped 0.2% increasing the annual rate up from 1.8% to 1.9%. As reported by the Bureau of Labor Statistics, energy costs decreased 4.7% in September following a 2% decline in August. Excluding energy alone, consumer prices increased 0.2% at the end of the third quarter. The producer price index (PPI) dropped by 0.5%. Excluding food and energy, PPI fell by 0.3% month-over-month. Year-over-year PPI decreased by 1.1%, but when food and energy were eliminated PPI increased by 0.8%. The ISM Manufacturing Index decreased more than expected falling from 51.1 to 50.2 in September, which reflected the lowest number since May 2013.

The Commerce Department said total retail sales increased 0.1% in September. Revisions were made to retail sales for August with a decrease from 0.2% to 0.0% and July up from 0.7% to 0.8%. When gasoline sales were

excluded, retail sales increased 0.4% for the month. Car dealerships sales rose 1.7% after increasing 0.4% the previous month. Clothing stores, sporting goods and hobby stores expanded sales by 0.9% and receipts at restaurants and bars increased 0.7%. Sales at electronics, appliance and online stores dropped 0.2%.

The National Association of Realtors reported that existing home sales in September increased 4.7% to a seasonally adjusted annual rate of 5.55 million from a slightly downwardly revised 5.30 million in August, and were 8.8% above a year ago. The median price of \$221,900 was reported for existing homes, which was 6.1% above September 2014. Foreclosures represented 6% and short sales were 1% of September total home sales.

The first estimate of the third quarter gross domestic product (GDP) was reported by the Bureau of Economic Analysis at 1.5%. Exports increased 1.9% for the third quarter, compared to a 5.1% gain in the previous quarter, and imports increased 1.8% in the third quarter.

Portfolio Commentary: Performance, Diversification, and Strategy

Yield on the Treasurer's portfolio was 1.75% in October and the weighted average maturity was 934 days. The year-to-date monthly average investable base was \$3.78 billion. Portfolio diversification continues to be sound. U.S. Treasury Inflation-Protected Securities represented 1% of holdings, and U.S. government sponsored enterprises accounted for approximately 44% of the portfolio. Mortgage-backed securities were 38%, municipal bonds were 2% and Certificates of Deposit represented 3% of assets. Money market mutual funds were 7% and OK Invest, which is comprised of various State agency funds, represented 3% of the total portfolio. State Bond Issues (at 2%) and foreign bonds (at less than 1%) made up the balance of funds invested. In keeping with the State's statutory investment objectives, the portfolio strategy continues to seek safety, liquidity, and return on investment, in that order. Laddered bond maturities and a buy-and-hold strategy were utilized. Market observation for investment opportunities were considered in order to maximize income within investment parameters and the current low interest rate environment.

Collateralization

All funds under the control of this office requiring collateralization were secured at rates ranging from 102% to 110%, depending on the type of investment.

Payments, Fees, and Commissions

All securities were purchased or sold on a net basis utilizing competitive bidding where practicable, with no additional fees or commissions known to the State Treasurer. Bank fees and mutual fund operating expenses are detailed in the attached pages, as is the earnings split between the Treasurer and the master custodian bank on securities lending income.

Total Funds Invested

Funds available for investment, at cost basis, include the State Treasurer's investments at \$3,729,937,925 and State Agency balances in OK Invest at \$2,425,338,003 for a total of \$6,155,275,928.



In December 2014, the Treasurer estimated earnings to the Board of Equalization for Fiscal Year 2016. The amount estimated was \$53,000,000. Year-to-date actual earnings are recorded on a cash basis of accounting.

Explanation of Performance Comparison October 31, 2015

The following page presents market rates of return on the Securities portion of the General Account and of the State's aggregated State Agency Accounts. The figures, which are dollar- and time-weighted, where appropriate, are calculated using the percentage change in market value (inclusive of accrued income) from the end of the prior month to the end of the reporting month. To ensure the integrity of the data, this information is provided by the Treasurer's custodian bank acting in its capacity as an external third party. As such, performance measurement is presently confined to those investments which are custodied at J. P. Morgan Chase & Co.

The Treasurer's office is trying to develop a method to report rates of return on all investment instruments in the State's portfolio. This is in an effort to report return data in a manner recommended on September 15, 1994, by the Working Group of the Cash Management and Investment Oversight Commission. However, there are technical and conceptual challenges to expanding performance measurement to other portions of the portfolio. Attempting to apply market-base pricing calculations to instruments which do not trade, such as Certificates of Deposit, presents difficulty which is both conceptual and technical in nature.



NOTE: Pursuant to Oklahoma State Statute Title 62, Section 89.7, all known fees are to be reported. The money market mutual fund fees reported above are shown at the contracted rate. Due to the current low interest rate environment, a portion of these fees have been voluntarily waived by the provider. An adjustment to actual fees will be presented in the Annual Report.

The State Treasurer participates in a Securities Lending Program with J. P. Morgan Chase & Co. acting as lending agent. J. P. Morgan retains 15% of the revenues generated as compensation for services. Its share for the month was \$906.67. Pursuant to Oklahoma State Statute Title 62 Section 90, the State Treasurer retains the first \$450,000 of securities lending revenues in a revolving fund. These funds are used to pay custody and other banking fees. Any revenue not needed for this purpose is deposited to the General Fund.
